



SUMMARY OF REGULATIONS

THE FOLLOWING REGULATIONS APPLY TO ALL LANDS INCLUDED IN THE MANAGEMENT AREA. ADDITIONAL RESTRICTIONS MAY ALSO APPLY. ADHERE TO ALL POSTED SIGNS OR PLACARDS.

It shall be unlawful to:

- Possess or consume alcoholic beverages.
- Camp or use campsites.
- Build, tend or maintain any fire within 75 feet of Spring Creek or on hatchery grounds or when the fire index rating is high, very high or extreme. Small fires for cooking or warming purposes are permitted in other areas, but they must be contained and attended at all times.
- Swim in any dam area, pond or stream.
- Plant, gather, dig, cut, disturb, remove or otherwise injure any plants or parts thereof, including trees, shrubs, vines, flowering plants and cultivated crops. Mushrooms and fruits of berry-producing plants may be picked for personal, non commercial use.
- Remove or attempt to remove any manmade or natural object except wildlife and fish lawfully taken during the open season in compliance with applicable laws and regulations. Objects which may not be removed include animals, rocks, minerals, sand, and historical or archeological artifacts.
- Disturb, destroy, mutilate, deface or remove any sign, placard, bulletin board or kiosk.
- Occupy, use or construct, place or maintain structures or other tangible property. Portable hunting blinds or stands may be used, provided no visible damage is caused to trees.
- Feed wildlife or place any food, fruit, hay, grain, chemical, salt or other mineral.
- Release domestic animals, captive-bred or captive-raised game or wildlife.
- Fail to have dogs leashed and under control while in the parking areas or on trails, or fail to scoop, contain and retain any droppings. Hunting dogs engaged in lawful hunting or training in compliance Title 34 PA. C. S. while outside parking areas are exempt from these restrictions.
- Discharge any firearm, bow and arrow, or device capable of launching projectiles that is not a lawful device to hunt game or wildlife or take fish.
- Engage in any commercial activity or utilize the property for any personal or organizational activity other than the intended use.
- Leave, emit or deposit any trash, refuse or garbage, or other debris on lands or in or along waters.
- Operate any vehicle not in compliance with Title 75 PA. C. S. or in any careless or reckless manner.
- Operate any non-motorized (except bicycles) or motorized vehicles (including ATVs, motorcycles, snowmobiles, etc.) or ride any animal on any lands or trails not posted as open to that type of vehicular travel.
- Launch or retrieve any watercraft not displaying a current registration or a current Pennsylvania launch permit.
- Be in the management area from November 15 through December 15 inclusive (except Sundays) when not engaged in lawful hunting or trapping and fail to wear a minimum of 250 square inches of daylight fluorescent orange-colored material on the head, chest and back, combined, or in lieu thereof a hat of the same colored material. The material shall be worn so that it is visible in a 360 degree arc. Persons within 75 feet of Spring Creek are not required but highly encouraged to wear the required fluorescent orange.
- Fail to comply with all other fishing, hunting and boating laws and regulations.
